What is happening in Southwark?

- Southwark council are building new council homes in and above buildings on some estates in the borough
- Find out if new homes are planned on your estate by looking <u>at this list</u> or <u>this map.</u>
- You have a right to be consulted on planning applications and plans that affect you.
- Planning decisions should promote equality protected groups must be considered.
- You can seek to influence the process by commenting on different aspects of planning applications and respond to consultations — Planning Aid London (PAL) can help you do this.
- Planning is only part of the story: organise, campaign and create to spread the word. Southwark Group of Tenants Organisation (SGTO) can help.
